

## Terms and conditions

- 1.) The present general terms and conditions apply to all business transactions of Sound M. Keller.
- 2.) Special agreements are only valid if they have been confirmed in writing.
- 3.) The rental pricelist includes net day prices per piece. Without transportation, assembly and disassembly, setting up.
- 4.) The online offers are valid only as long as they can be seen in the website, and while supplies last. The pictures of the products that are offered are only for illustration and is not binding. Sound M. Keller disclaims any responsibility for any errors or inaccuracies to the pictures, descriptions, explanations, and so on.
- 5.) By handover the customer has to bring a valid identification card and has to be able. Rental components are handle proper and careful. They are cleaned and in perfect condition on time back.
- 6.) If not otherwise provided for in the lease the tenant must pick up the goods and also in the same place again back.
- 7.) The objects according to lease are just hired and remain in possession of Sound M. Keller.
- 8.) After the contract remain the rental property for an agreed period reserved. If the tenant withdraws from the contract cancellation costs amount to: up to 60 days prior to arrival 5%, to 30 days 25%, to 10 days 50%, up to 3 days 75% and after 100%. Are already in the run or cancellations made preparations, which are the cancellation costs exceed, then provides Sound M. Keller actual cost to the tenant.
- 9.) The tenant is liable complete competence for each type of damage to rented accommodation, from camp starting up again camp entrance for installed all the damage from transportation, weather, improper operated, power failure, theft, dirt, third parties, etc. You are allowed only by instructed persons, serving be.
- 10.) By signing the lease the tenant confirmed that he has checked the goods and found as faultlessly. Retrospectively reported defects are not recognized by the owner.
- 11.) Broken or not returned components by tentant, made in restoring the original condition through Sound M. Keller in statement. The amount can reach up to the replacement value of the goods.
- 12.) Any kind of alteration to the rented accommodation is strictly prohibited by the landlord. Corresponding costs for an recovery are charged to the tenants.
- 13.) For the infrastructure, ail permits, charges vary, and so provides the tenant. Grid connection standards are adhered to. The systems must be connected behind a fault current circuit breaker device. Temporary power installations are to be performed by an electrician.
- 14.) Unless otherwise specified in the lease, the lessee does the loading and unloading, transportation, by himself. They are to use appropriate and closed vehicles.
- 15.) In case of theft or loss is to be always create a police report. By transport damages the tenant must arrange an inventory trough the forwarder.
- 16.) All changes to the lease require a simple writing. Payment is cash on handing the goods.
- 17.) If the tenant agreed helper / organizer are not on site, the resulting additional costs will be charged. Additional work on the contract will be charged with CHF 60.- per hour.
- 18.) The tenant must guarantee a liability, and other comprehensive insurance on stock and output until the goods are returned.
- 19.) All business connections are under the swiss law. The jurisdiction is determined by us.
- 20.) The tenant or his legal representative shall, with his signature of abstract. Rental conditions of Sound M. Keller.
